GENERAL MANAGER REPORT

UC HEALTH - 1500 PARK CENTRAL DRIVE

- A one-story addition on the northeast side of the existing medical office building consisting of 14,719 SF
- A six-story addition to the east side of the existing Hospital building consisting of 156,399 SF
- The project includes the renovation of 29,998 SF on levels G1, 1, and 2 of the existing medical office building and hospital

- Grading and leveling of the site to enable placement of the medical office building.
- Integration with existing hospital site circulation and parking configuration
- Total SF of project, including new construction and renovations is 201,116 SF

CONTRACT MANAGEMENT REVIEW

- Over the past year, staff has implemented an in-depth contract review initiative
- Efforts have provided annual savings of \$400,000
- Coupled with diligence and addressing the HRCA investment strategy, we are now yielding a \$660,000 annual increase in our investment portfolio
- Investments were made in FDIC insured Treasury Bonds and CDs

- All are secured in status and fall under our investment requirements outlined in the Community Declaration
- In total, this oversight has provided a positive impact on our annual budget that exceeds \$1M annually
